### **SALARY AND APPOINTMENT INFORMATION**

This is a 9-month, 100%-time academic tenure-track position with the opportunity for summer appointment. The expected start date is negotiable.

The budgeted salary range for these positions is \$190,000-\$200,000 at the Assistant Professor level, \$200,000-\$215,000 at the Associate Professor level, and \$215,000-\$255,000 at the Professor level. The pay offered to the selected candidate will be determined based on factors including (but not limited to) the experience and qualifications of the selected candidate including equivalent years in rank, training, and field or discipline; internal equity; and external market pay for comparable jobs.
